## PARKING REGULATIONS FOR THE MOTORHOME SITE IN ZELTINGEN AT THE BRIDGE

Operator: Municipality of Zeltingen-Rachtig

We would like to welcome you and wish you a pleasant stay at our camper site in Zeltingen-Rachtig.

To ensure that your stay runs smoothly, we kindly ask you to observe the following motorhome site regulations:

1. The Caravan site is usually open from March to November.
2. Upon arrival at the site, the required fee must be paid immediately at the designated machine. The corresponding ticket must be displayed in a clearly visible position in the vehicle behind the windscreen. Motorhomes that occupy more than one space pay double the fee.
3. By driving onto the site, you accept the parking regulations!
4. The site is checked several times a day by authorised persons of the local community. The motorhome site is not a permanent residence. The maximum duration of stay is 14 days. If you only want to park for a short while, you can use the spaces at the wall for a fee.
5. The use of the site is only permitted for self-sufficient motorhomes.  
**Not permitted:** tents, caravans and mobile homes without WC.
6. There are energy columns with sockets on the pitch, these are protected with 16 A. For the supply of fresh water, a supply station is available on the mobile home pitch. The use of electricity, supply and disposal station is included in the user fee. Washing of vehicles is not permitted. Disposal of faeces is only permitted in the disposal station. Please use only sanitary liquid that is labelled with the "Blue Angel".
7. The road traffic regulations apply on the motorhome site. Please drive at walking speed.
8. Barbecuing with charcoal or other smoke-producing combustibles is only permitted with approved equipment. Any nuisance
9. to other users caused by fire, flying sparks or smoke must of course be avoided. Fire extinguishers are compulsory on all pitches (fire classes A/B/C).
10. Dogs of all sizes must be kept on a leash at all times. Dog walking is only permitted outside the motorhome site, please remove "dog excrement" immediately. Dogs that fall under the fighting dog regulations are not allowed.
11. Night rest lasts from 10 p.m. to 6 a.m. The noise level must be reduced to a low volume during this time. Out of consideration for other users of the motorhome site, please avoid all activities that cause noise should during this time.
12. Please leave your pitch clean and dispose your trash properly and separately in the provided containers.
13. The use of the pitch is at your own risk. The site is not guarded. There is no winter service. The operator is not liable for damage caused by the failure of the electricity and/or drinking water supply or damage caused by other users, visitors or other third parties. The users are liable for all culpable, i.e. deliberate or negligent damage caused by non-observance of the pitch regulations.
14. The instructions of the groundsman must be followed; the staff employed are also entitled to issue bans. Furthermore, the staff is entitled to inspect personal data and to record vehicles without a valid ticket by means of photo documentation. In this case, the owner will receive an invoice for evasion of the usage fee. In addition to the parking space fee, this invoice will also contain a handling fee of 25 €. Failure to pay will result in a ban from the site.
